2. Services Provided

3. Eligibility

4. Bookings and Payments

All bookings must align with the following:

- All bookings must be made through the booking form available on our website or arranged directly through a Pilot Theory Online tutor, who will book the session on the client's behalf.
- Clients of Pilot Theory Online that purchase a 'Block Booking' have 12 months from the date of purchase to use all sessions within that 'Block Booking'.

All payments must align with the following:

- Payment must be completed at the time of booking via the methods provided.
